#### **Lawrence E. Blaha Memorial Award**

Lawrence E. Blaha Memorial Award is given every two years.

#### **Selection Criteria:**

- a. The individual must have at least ten years experience in the field of blindness and must have distinguished himself or herself in activities related to Orientation and Mobility such as:
  - contribute to the body of knowledge/literature
  - excel in a leadership manner in the provision of O&M services
- recruit or otherwise impact the decision of a large number of individuals to enter the field of Orientation and Mobility,
  - serve in a "mentor capacity" to a significant number of O&M professionals.
- b. The achievements being recognized must have had a significant impact upon the field of Orientation and Mobility.
- c. The individual must be an O&M Division member and be a Certified Orientation and Mobility Specialist unless retired or out of the field (administration).

d. Nominations and letters of support shall be made by members of the O&M Division with a letter of up to two pages in length. The number of letters submitted shall not influence the decision one way or the other.

## History:

The Lawrence E. Blaha Award was initiated in 1968 to honor people who have shown exemplary behavior in the field of O&M, made outstanding contributions to the profession, and shown dedication to serving people with visual impairments. It is the highest honor that the O&M Division can bestow. Each recipient of this award is the Guardian of Sir Francis Campbell's cane until it is passed along to the next award recipient. The handle of the cane was used by Sir Francis Campbell, and can be seen in a photograph of him that is displayed in the C. Warren Bledsoe Orientation and Mobility Archives.

This award was named in honor of Lawrence Blaha who was a pioneer in the field of O&M. He is remembered for his wit, athletic abilities, philosophy, technical skill and his high standards. He was an educator whose ideas are remembered and continued through this award. In 1948, he began his career working with people with visual impairments at the Central Blind Rehabilitation Center for Visually Impaired and Blinded Veterans, VA Hospital, Hines, Illinois. He was one of a group of six individuals chosen for training to become the original O&M specialists at Hines. In 1961, he joined the faculty of Western Michigan University; from 1964 until his sudden death, he was Director of the O&M program at California State College, Los Angeles. The first Lawrence E. Blaha Award was given to him posthumously in 1968.

Sir Francis Campbell, whose cane handle is passed along to award recipients, was an American expatriate who was knighted by King Edward VII. Campbell was born in Tennessee and accidentally blinded before he was six. He was educated at the Tennessee State Institute for the Blind and at the University of Tennessee. Campbell taught music at the Perkins School for the Blind. At Perkins, he was involved in early efforts to teach Orientation and Mobility.

### The Orientation and Mobility Citation of Excellence for Direct Service

Orientation and Mobility Citation of Excellence for Direct Service is given only when a worthy nominee has been nominated.

Selection Criteria:

- a. The individual must be in direct service the year preceding the AER International Conference teaching Orientation and Mobility to either children or adults for a period of 5-10 years.
- b. The individual must be an O&M Division member and be a Certified Orientation and Mobility Specialist.

## History:

The Orientation and Mobility Citation of Excellence for Direct Service was established in 1985 to present "to a younger member of the profession, to encourage O&M specialists whose present excellent teaching records already foreshadow promising careers in our profession" (1996-97 Division newsletter). It continues to be awarded to recognize individuals who have made significant contributions to the profession during the first ten years of their career in O&M and to encourage these individuals to continue their promising careers in our profession.

## The Sandy Kronick Distinguished Service Award

The Sandy Kronick Distinguished Service Award is given only when a worthy nominee has been nominated.

#### **Selection Criteria:**

- a. The individual must have had at least ten years experience in the field of blindness with the majority of professional career in direct service teaching O&M to visually impaired people; and have demonstrated distinguished service by doing one or more of the following:
- extend beyond the usual job requirements by using talents and expertise to enhance the field of O&M
  - · initiate innovative or unique programs
  - serve as a mentor to other O&M specialists
  - · present at local, regional, or international conferences
  - publish work in a professional journal
- b. The individual must have been a longstanding member of the O&M Division (majority of career) and be a Certified Orientation and Mobility Specialist unless retired or out of the field (administration).

c. The individual must exemplify the standards outlined in the O&M Code of Ethics.

### **History**

The Sandy Kronick Distinguished Service Award was established in 1994 to recognize professionals who demonstrate distinguished service in O&M through a long-term commitment in direct service. The award was named after Sandy Kronick because of his lifelong commitment and dedication to teaching O&M to visually impaired people. He taught O&M in Oregon until his sudden death in May 1993. The first Sandy Kronick Distinguished Service Award was given to him posthumously and accepted by his wife, Bethanne Kronick, at the 1994 AER International Conference in Dallas. Sandy Kronick was chosen as the first recipient of this award because of his lifelong dedication to teaching Orientation and Mobility, while continuing to be actively involved with numerous professional activities and committees.

Mr. Kronick was a very active member of AER, especially during his last ten years. He was instrumental in forming the Oregon AER Chapter and served as its president. He served on several international committees and had just completed his term as AER's Northwest Regional Rehabilitation Representative at the time of his death.

The establishment of this award is a fitting tribute to Sandy Kronick and to all the O&M specialists who forego promotions or higher paying career changes in order to continue doing what they know and love best, namely teach Orientation and Mobility. The award will be given only when a worthy recipient is determined.

# A child's first steps with a cane. Why not try the Dakota Disk?

By now I would hope that most COMS in the United States have heard of the Dakota Disk and understand how it can be used on rough terrain and snow. Although the original goal was to develop a tip that was superior for rugged, outdoor conditions, I realized that it could also be ideal for preschoolers just learning how to explore and move with a cane. Push toys and pre-cane devices may often be the first tools to aid in movement, but I contend that a child-sized cane with a Dakota Disk might be just the combination to take learning to the next level.

It is a fun and rewarding experience guiding a young cane user to reach out and encounter the world. Ideally it is time to introduce prerequisite language and space concepts. At the same time it is imperative that we teach crucial safety concepts at this stage. The COMS must intervene wisely during lessons while allowing minor bumps and contact with objects.

This is how we let children interact with the objects and spaces around them in a real and meaningful way. When the cane tip goes over a curb or step there must be the recognition of risk and hopefully all movement ceases. It is imperative that cane users of any age feel the tip go over and react accordingly. I believe it is a universal experience, however, that new cane users often fail to make this connection at first. The subtle changes in sound and position of the cane and arm do not always register with the child as strongly as we would like. There is a high likelihood that the child will keep walking and falling. We deal with this by carefully monitoring, verbal cautions and physical intervention when necessary.

We have this wonderful opportunity to guide the young cane user while learning real life consequences and how to problem solve. This is mostly a cognitive exercise, but we also try to put developmentally appropriate tools in the hands of all our students. I believe that the Dakota Disk tip on an appropriately sized cane (including handle) is a sound developmental choice for many children.

Let me explain why I feel that the Dakota Disk tip can be especially helpful. It has a much larger surface area to contact the floor or ground. Surface changes are readily detected and objects in one's path are more likely to be located compared to other cane tips. I will concede that push toys and pre-cane devices are the fun and practical first tools of choice with little ones when they're first gaining confidence with forward movement. We should be thinking about the next phase of training. When we do determine that



it is time for a child to try a cane, we want their experience to be positive and effective. As the child moves forward with cane in hand, we guide him or her to keep it in front and even move it from side to side to a limited degree to search for objects like furniture or toys. I suggest that the success rate for finding specific objects will be much higher with the Dakota Disk. The 6-inch disk easily slides over surfaces and by virtue of its size will find targets much more readily. Furthermore, even though the disk is lightweight, the new cane user is not as likely to lift the cane into the air which becomes a safety hazard. The cane with disk tip is appropriate to take out into the community and it will be perfect for grassy areas and playgrounds. The same cannot be said for push toys.

Recognizing that the cane is more than an object detector, we know that it is an extension of the hand to learn about the world. Nevertheless, it is our role and responsibility to help children understand that this awesome tool serves a very important purpose for safety. It detects objects and drop-offs that the child must react to in order to be safe. When used both indoors and outdoors the tactile and sound cues are very noticeable which makes it easier to reinforce the subtle changes that will be meaningful to the traveler. The sensory cues provided by the flat underside of the tip are more obvious than other tips. This effect seems to be greatly enhanced because the surface area is much greater than any other cane tip available. In the same way, one of the most obvious benefits of the large tip is that it is unmistakable when it slides over steps or curbs. In my years of working with children of

all ages, I can attest that many do not quickly react to drop-offs or low lying objects. It has been my experience under blindfold myself that recognition of all hazards is enhanced.

At this point I have only anecdotal evidence to support my impressions that the Dakota Disk is a practical and desirable option for preschool children using a cane. I suggest for most children that moving on to other tip styles should be expected. This should always be determined through careful consideration by a team, however, and there may be some children who would be successful with this tip style in the long-term. Individuals with other physical limitations may also be good candidates for using a Dakota Disk tip with a standard cane.

I welcome those of you who have tried the tip to give it a try with a younger student. I do not think you will be disappointed. I would also be thrilled to have some hard research done with the tip for both adults and children. It is important for me to note that I have no financial benefit from the sale of this Ambutech product. I merely want to provide more awareness so that every potentially beneficial tool is made available to the children and adults we serve. # Randolph-Sheppard Act Employment Program

The Randolph-Sheppard Act was sponsored by Representative Jennings Randolph and Senator Morris Sheppard and signed into law on June 20, 1936 by President Franklin D. Roosevelt. The purpose is to provide employment opportunities for blind individuals in the United States. On December 7, 1974, the inactment of the 1974 Amendments to the Randolph-Sheppard Act greatly improved the Act. The Business Enterprise Program (BEP) is federally mandated and is administered in each state by a designated State Licensing Agency (SLA). The Randolph-Sheppard Program gives blind persons the first right of refusal to operate food service facilities in federally owned government buildings in all 50 states. Most states also have mini Randolph-Sheppard Act laws so these businesses are primarily operated in city, county, state, and federal facilities. They include snack bars, cafeterias, vending machine facilities, vending machine routes, highway rest areas, visitor welcome centers, gift shops, convenience stores, and food service locations on military bases. These facilities generate over \$750,000,000 a year in sales, making the Randolph-Sheppard Program the 7th largest foodservice program in the nation.

RANDOLPH-SHEPPARD VENDORS OF AMERICA® (RSVA®) is a national membership organization committed to improving economic opportunities for blind vendors/managers. RSVA® promotes independent and effective participation in the Business Enterprise Program and encourages the creation of new business opportunities. This volunteer organization is composed of blind and visually impaired vendors and those individuals who support the Randolph-Sheppard Program. The purpose is to bring together blind persons engaged in the operation of vending facilities and individuals and groups supporting the goals and objectives of this organization and the Randolph-Sheppard vending facility program. RSVA® is an affiliate of the American Council of the Blind (ACB), America's leading consumer based advocacy organization working on behalf of all blind and visually impaired individuals.

RSVA® promotes the general welfare of blind vendors nationwide who are engaged in RS businesses and provides forums for discussion of issues affecting licensed blind managers in the Randolph-Sheppard program. RSVA partners in the development of practical, profitable self-help activities by working to improve the education and training available to blind vendors/managers through two national conferences, the RSVA® sponsored

Sagebrush National Business Enterprise Program training Conference and the annual summer national RSVA®-ACB conference. RSVA® provides technical and legal support to vendors/managers to ensure rights granted to them are not limited or voided by actions of property managers or State Licensing Agencies. Other services include legal consultation, advice, and assistance to promote the legal interest of blind vendors seeking proper implementation of the Randolph-Sheppard Act.

RSVA® can provide speakers at meetings or conferences to promote the Randolph-Sheppard Program. RSVA membership offers the opportunity for fellowship with peers, meet experts in the field, and participate in the governance of an organization important to a vendor's livelihood. RSVA®, with support from the ACB, monitors actions of legislative and regulatory bodies affecting the lives and businesses of blind vendors. RSVA® believes in promoting a positive image of blind vendors/managers as hard working, tax paying citizens who are contributing to the economy of the communities where they work.
