#### New AFB & APH Partnership

Several information resources founded by the American Foundation for the Blind (AFB) are coming under the stewardship of the American Printing House for the Blind (APH), as the result of a new partnership between the two agencies designed to ensure the continued impact of those services and to enable AFB to focus on policy and programs geared to creating a more accessible and equitable society. One example is book publishing (AFB Press). Other resources, which APH will group under the name APH ConnectCenter, include:

- 1. <u>FamilyConnect.org</u>—connects parents of blind kids with resources and peers.
- 2. <u>CareerConnect</u>—provides employment information, career exploration tools and job-search guidance for the blind and related professionals.
- 3. <u>VisionAware.org</u>—provides information, step-by-step daily living techniques and a supportive online community for adventitiously blind adults.
- 4. <u>BrailleBug.org</u>—teaches children about braille through games and activities and provides resources for teachers and parents.
- 5. <u>Directory of Services</u>—over 3,500 agencies in Canada and the United States are listed.

#### **ACVREP Modifies Certification Timeline**

The Board of Directors of the Academy for Certification of Vision Rehabilitation and Education Professionals (ACVREP) has modified the requirements for applicants to pass the exam within the current guidelines of 24 months. Currently, an applicant must pass the certification exam within a period of 24 months from their initial exam registration date or the applicant's Eligibility is canceled, and the applicant must reapply for Eligibility if the applicant wishes to continue to pursue certification.

In reviewing exam data, the Board determined that applicants who did not pass the exam the first time were very quickly rescheduling a retake and often did not pass the second time. There have been applicants who have taken the exam 6+ times and still have not passed. As a result, the Board, in order to encourage more preparation between exam retakes, has limited the number of times an applicant can take the exam within the 24-month period to four times.

For example, if an applicant takes and fails the exam four times within, say, 18 months of their initial exam registration date, their Eligibility will be canceled even though there are six months remaining in the 24-month period. With this rule change, the Board is hoping to encourage applicants to allow enough time between their exams to study sufficiently so that they pass the certification exam within the 24-month period.

The new rule becomes effective for any applicant whose initial exam registration is October 1, 2018, or after.

### New Proposed Online CATIS Graduate Certificate

The University of Massachusetts Boston will launch its new online curriculum to support Vision Education and Rehabilitation Specialists wishing to prepare for ACVREP examination to become a Certified Assistive Technology Instructional Specialist for People with Visual Impairments (CATIS). A CATIS engages in a comprehensive approach to vision rehabilitation addressing visual, physical, cognitive and psychosocial aspects related to the training and integration of existing and emerging technologies. Methods and strategies include the use of visual and non-visual techniques, strategies and problem-solving skills through the use of various Assistive Technology devices and solutions.

#### **Core Courses:**

- 1. Introduction to Assistive Technology for People with Visual Impairments (3 credits) Scheduled Fall 2018 cost \$1400
- 2. Assistive Technology Assessment and Instruction for People with Visual Impairments (4 credits) Scheduled Spring 2019 cost \$1400
- 3. Configuration and Exploration of Assistive Technology Solutions (4 credits) Scheduled Summer 2019 cost \$1400
- 4. Technological Methods of Accessibility and Accommodations for People with Visual Impairments (3 credits) Scheduled Fall 2019 cost \$1400
- 5. Internship for Assistive Technology Instruction for People with Visual Impairments (4 credits) Scheduled Spring 2020 cost \$1400

# COAST TO COAST TO COAST

#### The Accessible Canada Act

Following consultations with Canadians, Kirsty Duncan, Minister of Sport & Persons with Disabilities, introduced historic accessibility legislation to Parliament on June 20, 2018. Bill C-81, also known as the Accessible Canada Act, will ensure that people with disabilities, including those who are blind or visually impaired, can fully participate and have an equal opportunity within federally regulated jurisdictions. Once approved by Parliament, the Act would add to existing rights and freedoms for people with disabilities, including the Canadian Charter of Rights and Freedoms, the Canadian Human Rights Act and Canada's approval of the United Nations Convention on the Rights of Persons with Disabilities. The Government of Canada has committed to implementing the Act within five years.

#### Marrakesh Treaty Guide for Librarians

On August 27, 2018, at the International Federation of Library Associations and Institutions (IFLA) World Library and Information Congress held in Kuala Lumpur, Malaysia, Electronic Information for Libraries (EIFL) co-launched a new practical guide to the Marrakesh Treaty for persons with print disabilities. The new guide, titled "Getting Started. Implementing the Marrakesh Treaty for persons with print disabilities. A practical guide for librarians", is mainly aimed at librarians in countries that have joined the Marrakesh Treaty, and where national implementation is completed or advanced.

The guide is jointly published by IFLA, the World Blind Union, EIFL, the Canadian Association of Research Libraries and the University of Toronto Scarborough.
