A new course, <u>Social Isolation</u>, <u>Aging</u>, <u>and Vision Loss</u> (1 hour), has been added to our <u>course</u> <u>catalog</u>. Social isolation can affect anyone of any age. In this course, Dr. Sheffield discusses factors like age, vision impairment, and overall health status and how they contribute to placing individuals at higher risk for social isolation. Evidenced-based strategies to combat social isolation are provided. Additionally, the course looks at vision rehabilitation and its role in reducing social isolation.

### **New Course: Mobility Impairments: Implications for Service Providers**

A mobility impairment might affect an individual's ability to walk, climb stairs, use their hands, or complete activities of daily living. This course covers numerous health conditions that often cause mobility impairments and suggests safe, collaborative ways to provide blind/vision rehabilitation services. Physical and occupational therapists' roles are reviewed, and suggestions are made for how to work together to provide comprehensive and effective services. Additionally, this course will help individuals identify program participants with mobility impairments for federal reporting. Audrey Demmitt and Trina Bassak wrote this course. It is available for 2 hours of CRC, ACVREP, and NBPCB credit.

### New course: How Social Determinants of Health Relate to Vision and Aging

Social determinants are defined by the World Health Organization as the "conditions in which people are born, grow, live, work, and age." In this course, Dr. Pricilla Rogers looks at these social determinants and how these factors impact the prevalence of vision loss. Discussion focuses on how individuals with vision impairment or blindness are at greater risk for additional health impairments and consider strategies for how service providers can ease the effects of social determinants. It is available for 1 hour of CRC, ACVREP, and NBPCB credit.

# New course: <u>Fall Prevention: Interventions for Older Individuals who are Visually</u> Impaired

Falls are the leading cause of injury among older adults. Having vision loss puts an individual at higher risk for falls. In this course, an interdisciplinary team from Vision Services for the Blind and Visually Impaired, a non-profit agency in New York, focuses on this important topic. Learn how to identify individuals at risk for falls, learn about home safety checklists, and modifications and strategies to help prevent falls. This course was written by William Hixson, Travis Joseph, Teddy Kern, and Julie Spodnick and is available for 1-hour CRC, ACVREP, and NBPCB credit.

#### **Low Vision Tablet and Phone Stand**

For some time now, and especially during the pandemic, TVI's, CVRT's and COMS have observed that tablets and phones are frequently being used by individuals to aid in daily activities like text and image enlargement, image magnification, and video chatting. We also find that posture

is typically poor because our clients need to hunch over to view the screen on a table. Given the extra screen time during the pandemic, the issue is even worse.

Below is some information on a new device with you that can significantly help. Our Vermont CATIS and AER member, Allie Futty, partnered with a local design engineer at Blue Vista Creations, and they developed a device stand specifically to help low vision users. The stand is highly adjustable and supports nearly any tablet or phone for comfortable ergonomic viewing at the distance and height that low vision users need. One version holds standard size devices and has a low-profile base for easy portability. Another version holds the largest of devices, including a case, and has a larger base for additional stability. The online Certificate course is available FREE to both consumers and professionals.

Those who successfully complete the training will receive a digital badge to display that confirms that they are a Chromebook Accessibility Expert.

Professionals will be able to hone their skills in teaching use of the Chromebook and consumers can expand their professional opportunities and be more skilled in using this well priced computer with built in accessibility.

#### Meet AER member, Joyce Lopez, who joined us in 1993!

Ms. A. Joyce Lopez is a Certified Orientation & Mobility Specialist (COMS®) for the Texas Workforce Commission-Vocational Rehabilitation Services in Corpus Christi, Texas. She received a Bachelor of Science degree in Education from The University of Texas-Austin with specializations in Deficient Vision and Mental Retardation with a minor in Psychology. She returned to the university and received her O&M certification. Her career in the blindness field spans over 38 years.

Ms. Lopez was a teacher for the blind and visually impaired in the McAllen Independent School District for four years and then returned to her native home in Corpus Christi, Texas to take on a new job. She worked for the

Education Service Center, Region 2 as a Consultant for the Program for the Visually Impaired for 16 years. She worked with blind and visually impaired students and their assigned educators, administrators, and other professional staff. During her tenure at the ESC-2 she began working part time as a contractor for the legacy agency Texas Commission for the Blind providing Orientation & Mobility training (O&M) to their consumers. The rehabilitation field offered some new changes and challenges for her.

Ms. Lopez left her education career and began her rehabilitation career at the legacy agency DARS-Division for Blind Services in August 2006 as one of three O&M Specialists selected to work in the State of Texas. After spending five years in the Rio Grande Valley establishing an O&M program it was time for her to return to her native home by the bay! She continues to work as an Orientation & Mobility Specialist (COMS®) for the Texas Workforce Commission-Vocational Rehabilitation Services in Corpus Christi, Texas.
