## **Rhode Island's Blind and Visually Impaired Students**

Our friends, my bosses, and your colleagues in our Northeast AER chapter, and particularly from Rhode Island, have alerted us to an outrageous development in their neck of the woods that so obviously puts the instructional needs of kids who are blind or visually impaired in peril. The long and the short of it is that well more than a dozen TVIs and O&Mers were abruptly given their walking papers and told they are no longer needed after June 30. There are lots of twists and turns here, but it boils down to authorities in RI having some yet-to-be fully disclosed plans to award BVI-related educational service delivery to an unknown vendor who, of course, may not hire any of the current instructors or who may not at all be committed to maintaining the credential and experience level of the instructors that students in RI benefit from today. There are unflattering rumors flying around in RI about which vendor(s) have been in the mix conniving with state authorities who have been anything but transparent with the families of BVI kiddos who are naturally frightened and outraged.

So, on behalf of our AER sisters and brothers in RI and with the encouragement of the leadership of our Northeast AER chapter, I urge you all to read a bit more about what parents and advocates are doing about this nonsense and to join the petition which they have created. I promise you that this will be the easiest few minutes of righteous activism you'll engage in these days. Don't think you can make a difference? Well here's one way you can be sure the addition of your voice might just change the world, and by doing so, you're supporting, in a most tangible way, those of your colleagues in RI whose jobs are on the chopping block and whose students and families want so very much to continue!

#### New course – "Understanding People Living with Dementia and Vision Loss"

Catherine Tedder, registered nurse, dementia trainer, and coach, shares information and strategies to work with individuals with dementia. Reduced visual fields and misperceptions of visual images may cause fear and difficult behaviors in individuals who have dementia. This course, based on Teepa Snow's work with dementia patients, provides information about dementia, the stages of dementia, and suggests strategies for interacting with individuals who have dementia who have dementia and vision loss.

Text versions of our updated Lessons for Living are now available for download. These 19 lessons, written for the consumer, address topics like understanding eye conditions, visiting the eye doctor, learning how to use other senses, low vision, labeling and organization, adapting tasks, recreation and leisure, adjusting to vision loss, and accessing a computer or smartphone. Information provided will be helpful to individuals of any age who are facing vision loss. Coming soon, Lessons for Living will also be available in an audio format.

#### Safe Toddles

Safe Toddles is a non-profit organization founded in 2018. Our mission is to provide toddlers who are blind with a solution for walking safely— a pediatric belt cane for clear path detection. It is a simple tool for toddlers with visual impairments, a rectangular cane frame that connects to a belt with magnets. A unique ball bearing cane tip design enables the base to slide across most surfaces. When toddlers who are blind wear their canes most of the day they are protected from most bodily collisions. This allows them to build confidence to explore and learn.

Safe Toddles was co-founded by Dr. Grace Ambrose-Zaken, a certified orientation and mobility specialist (COMS) and Professor Marom Bikson, a biomedical engineer. Safe Toddles cares about our COMS community and creating effective new mobility tools to better meet the complex needs of our heterogeneous population.
