2022 AER Biennial International Conference Update: Session Proposals Deadline Extended!

The 2022 AER Biennial International Conference session proposal site deadline has been extended to **December 1, 2021**! Put in a proposal to present something you've been working on or sign up a presenting team to share together!

The following items are required to complete your submission:

- · Presenter Biography and Headshot
- Session Title, Description, and Knowledge Level
- Topic and Type
- Presentation Summary
- Three Learning Objectives

The conference will be held in person from July 20-24, 2022, in St. Louis, Missouri.

AER Accreditation Program to Pursue CHEA Recognition

AER Accreditation Council is pleased to report that we have made significant progress toward the goal of being recognized by CHEA. As important as accreditation is for university personnel preparation programs as well as organizations and schools that provide direct service to people with vision impairments, it is equally important that AER's accreditation program meets rigorous standards. CHEA is the body that offers this opportunity for self-study, continuous improvement, and independent review. Whereas AER Accreditation

Program confers accreditation of personnel programs, CHEA confers recognition of accrediting bodies.

The AER Accreditation Page on www.aerbvi.org is being updated to meet CHEA standards. It already has gotten some fresh new features:

- A page explaining how to become a Reviewer.
- An interactive map showing all the personnel preparation programs in the US and Canada.
- A listing of all AER Accredited Higher Education Programs by discipline: O&M, VRT, TVI, LVT. And when the Assistive Technology programs have been functioning for a year with at least one student, they will be eligible for the AT accreditation.
- Updated AER Policies and Procedures Manual with clearer definitions and new policies required by CHEA.
- Updated HEAC Handbook and OSAC Handbook (Organizations and Schools), synchronized with the Policies Manual.
- Easily downloadable forms and standards/self-study materials.
- Updated self-study forms with clearer instructions.
- AERAC Annual Impact Statement for 2020.

Coming Soon:

- AERAC Annual Impact Statement for 2021.
- Per CHEA Standards, Decision Reports on each program review, that show the recommendations by HEAC and the subsequent approval of those recommendations by AERAC, will be in a folder on the website open to consumers and the public.
- Per CHEA Standards, the website will post Expiration Dates for personnel preparation programs and announcements of programs who have submitted their Letter of Intent and are pursuing accreditation/reaccreditation.
- Per CHEA Standards, AER will post aggregate information on student performance for each HEAC program. Each university program that is accredited will have to meet a new standard that requires at least making a link to the AER posting from the university program's own web page, but preferably posting the results directly on its own webpage.

The Value of Accreditation to Higher Education Personnel Preparation Programs Higher Education Programs providing personnel preparation programs in Orientation & Mobility, Vision Rehabilitation Therapy, Teachers of Students with Visual Impairments, Low Vision Therapy, and Assistive Technology Instruction benefit from AER Accreditation in multiple ways. However, universities who are accredited may wonder what value is derived in a special program at that university receiving its own accreditation.

Accreditation provides assurance of the high quality of specialized curricula.

 The primary determining factor indicating a program within an accredited university must also be accredited is the degree of specialization of the curriculum.

- A specialized curriculum requires specialized expertise in the accreditor.
- Preparation programs for individuals seeking to work with individuals who
 are blind or visually impaired are, by
 definition, using specialized curricula. The experience and knowledge
 of faculty and the challenges of research all are unique and specific.
- Standards used by the AER Higher Education Accreditation Commission (HEAC) are developed and reviewed by highly regarded university professionals with backgrounds in the fields of study that produce the highly skilled instructors that serve people living with vision loss.

Accreditation is a form of Consumer Protection that often is followed by government regulation.

- Students looking for a program, check to make sure the one that interests them is accredited.
- Government regulation is tied to federal funding.
- Federal and private scholarships are granted according to the accreditation of programs attended by recipients.
- A call for consumer protection invariably is followed by government regulation, which often is tied to federal funding.
- Federal and private scholarships are granted according to the accreditation of programs attended by recipients.
- States require graduation from accredited programs for individuals to sit for licensure examinations.
- VA leadership has advised AERAC that they are considering requiring that all interns must come from accredited higher education programs and the accreditation must be conferred by organizations who are themselves accredited/"recognized" by either CHEA or the US Dept of Education.

AER Accreditation Council (AERAC) operates independently of the AERBVI Board. AERAC has two Commissions: OSAC (Organizations and Schools Accreditation Commission) and HEAC (Higher Education Accreditation Commission).
