AER recognizes the outstanding achievements of individuals working in our field through our biennial Awards program. We are pleased to announce the 2022 AER Awards nomination process is now open!

#### <u>Alfred Allen Award</u>

Honors professionals who have spent their careers in direct service to people with visual impairments. Through the extent and quality of the services that they have provided, these professionals exemplify the character, dedication, insight, and sharing that epitomize the spirit of and commitment to direct service.

#### Mary K. Bauman Award

Honors an individual who has made significant and outstanding contributions to the education of children and youth who are blind or visually impaired.

#### • C. Warren Bledsoe Award

Is given in recognition of a particularly noteworthy piece of literature in the field of blindness.

#### Douglas C. MacFarland Award

Honors an individual who has provided leadership in the field of blindness and visual impairment and who

made innovative, significant, or outstanding contributions to the education or rehabilitation of people who are visually impaired through either direct service, professional organizations, research, literature and/or preparation of professionals and is retired from the field. These contributions should have had an impact on a national or international level.

#### • John H. McAulay Award

Honor professionals who have contributed outstanding efforts and achievements leading to the placement of people with visual impairments in productive employment.

#### Outstanding Chapter Award

Recognizes a chapter whose membership efforts have been outstanding. Criteria includes: increase in the number of members; the number and quality of services and/or programs offered by the chapter; and legislative activity significantly affecting the lives of blind people.

#### <u>Ambrose M. Shotwell Award</u>

Was established to honor an individual who has made significant outstanding contributions to the personal adjustment or rehabilitation of adults who are blind or visually impaired.

#### <u>Richard L. Welsch Award</u>

Was established to recognize professionals who have contributed outstanding efforts in**AER chapter leadership**. Nominees will demonstrate activity and achievement, either past or current, in the role of AER President-Elect, President, Past-President, Secretary, or Treasurer at the chapter level.

## 2022 AER William and Dorothy Ferrell Scholarship!

AER proudly offers educational scholarships for individuals continuing their education in the field of providing services to the blind and visually impaired. The William and Dorothy Ferrell Scholarship is awarded every other year in even years to two selected applicants who are legally blind and are studying for a career in the field of services to persons who are blind or visually impaired.

### Help us honor difference-makers in the blindness field

As colleagues in the blindness field, all of us work on a daily basis with others who strive to enable and empower people who are blind or have low vision to thrive in the classroom, the workplace, and in their daily lives. These friends and colleagues are worthy of recognition, and that is where your valuable recommendations come in. We need your nominations to acknowledge the outstanding contributions of these individuals!

The <u>Migel Medal</u> is the highest honor in the blindness field, given annually by the American Foundation for the Blind (AFB) to exceptionally deserving recipients whose dedication and achievements have significantly <u>improved the lives of people who are blind or visually impaired</u>.

The Migel Medal Awards Committee selects just two honorees each year. Nominees should be those whose work affects services on a national level. The first Migel Medal is bestowed to a professional in the field of blindness whose contributions have significantly improved the lives of people who are blind or visually impaired. Prospective candidates include individuals with training and expertise in education, orientation and mobility, vision rehabilitation therapy, technology, personnel preparation, health, administration, or a related field.

The second Migel Medal is reserved for an individual who works outside the traditional field of blindness, but whose career accomplishments or innovations significantly improve the lives of people who are blind or visually impaired.

Nominations should be e-mailed to <u>afblc@afb.org</u> with "Migel Medal nomination" in the subject line. Nominators should send a one-page description of the nominee and accomplishments, and must also submit two letters of recommendation with the nomination from those familiar with their work. We have extended the deadline from February 1 to February 28. The medals will be bestowed at a special ceremony later this year.

One of the most powerful affirmations we can bestow on our team members in the field is the gift of well-earned recognition. Please take a moment to reflect and nominate a deserving colleague.

### Participants Needed For Research on Data Sonification

We are researchers studying how to use sound techniques, such as sonification, to convey meaningful aspects of ocean science data to increase access to ocean data and ocean literacy.

Initially, we will conduct small group design sessions, some with teachers who work with students who have vision impairment, (and different groups with experts in ocean data concepts).

During the session, you will be asked to share with the researchers all the ways you use sound in the classroom, including (if applicable) for communicating quantitative information (data).

The study is part of an NSF-funded Advancing Informal STEM Learning (AISL) collaboration between Woods Hole Oceanographic Institution, Georgia Institute of Technology, University of Oregon, and Your Ocean Consulting, Inc.

We are seeking interested teachers in any subject that includes data, e.g., Any and all of the sciences, mathematics, statistics, and social science, and who work with students with visual impairments.

You will be grouped with 2-5 other participants for a session. We plan to hold these sessions over Zoom. The meeting should take **no more** than 60 minutes. Unfortunately, there is no compensation for your participation. But hopefully you will find great satisfaction in contributing to research that will help make data more *accessible to all learners.*
