## A NOTE FROM OUR EXECUTIVE DIRECTOR

Hello AER!

September: the final days of summer, that last weekend trip to the lake for Labor Day, school in full swing for students and faculty, county fairs, and the return of Friday Night Lights. For AER, it's a month of final preparations for the fall conference season, initial phases of budget preparation, the first meeting of newly formed Board Committees, and hopefully the announcement of the 2024 AER International Conference location.

I shared last month that I planned on announcing the host city for the 2024 AER International Conference by September 1<sup>st</sup>, but regrettably, I won't be able to do that. I have discovered that the city that is the top selection for 2024 is significantly more expensive than I originally thought. If negotiations are successful, then we will announce the host city later this month. If not, then it's back to Google maps and the drawing board. I'll keep you posted.

This past week I began work on AER's 2023-2024 Biennial Budget. In 2021, AER converted from an annual to a biennial budget to align the financial operations of the association with programming and conference scheduling. On August 29<sup>th</sup>, I emailed the leadership of AER's 16 divisions requesting information that I will need for the budget. If you are a division leader and did not receive my email, please let me know as soon as possible.

This past month I joined the Georgia AER Board of Directors for their monthly meeting. It was great to hear the positive report from those who attended the conference in St. Louis, but more so to hear the excitement as they discussed their chapter conference for Spring 2023. The agenda item that really caught my attention though was their goal to increase their chapter membership by 50% before December 2022, and I'm certain they will meet it. This week I

shared with the Membership Committee that I have a goal of 4,000 members by the 40<sup>th</sup> Anniversary Conference in 2024, but after thinking about the GAER's goal, I will be raising that number. Chapter Presidents, please send me the name and email of your Membership Committee Chair/Board Member, I will need their assistance with this project.

My daughters started the fall semester last week at Texas Tech. Many of our members are back in the college classroom as well, either as faculty or students. I have one final request. #### **Bill of Rights for Children**

It is the beginning of another new school year. Are you excited about being with students again and all the possibilities? For those of you who are teachers, O&M specialists or other professionals in education this is always an exciting time. Everything is just perfect....right? Wait. You do have some concerns about some of your students getting the support, time and resources they need? You are a little worried about some of your students not getting enough time in all areas of the expanded core curriculum? Some of the parents tell you their concerns about their children and need help advocating at IEP meetings?

Yes we are doing a great job and yes we are excited but there are real challenges for our students. There are gaps and there is often a great deal of awareness needed among our education colleagues and administrators. Your experience and your voice are critical in helping develop plans that really do provide FAPE. Are you using the "Bill of Rights for All Children and their Families that are Visually Impaired" to educate and advocate for your students? It is a resource that is at your fingertips when you need it. It simply reinforces the things you know are needed and helps explain to other team members a few well established special education laws and a few ideals that we hold up as rights for our kids who do deserve the best education we can provide.

The Bill of Rights was written as a joint project by the Council of Schools and Services for the Blind and AER prior to Covid hitting and it is as relevant as ever as we move into a new period of time with renewed expectations. Please review it yourself, print it and hand it to parents, bring it to your general education peers. It is the beginning of a conversation in your team to help you design the best plan you can.

#### **AER Accreditation Web Page Updates**

Both the Higher Education Accreditation page and the Organizations and Schools page have been updated over the summer.

Higher Education Accreditation (HEAC) resources are here: <u>https://aerbvi.org/the-national-accreditation-council/higher-</u> education/

Check out the listings for O&M, VRT, TVI, LVT and AT. Changes include expiration dates for each listing, additional entries for TVI programs on the map, and a link to Accreditation Decision Summaries and Reports. This link is a completely new component of this page and is required by the Council for Higher Education Accreditation (CHEA). AER is pursuing recognition of its Higher Education Accreditation from CHEA. The link provides the most recent Annual Report from each accredited program and a summary of the AER Accreditation Council decision process leading to Full Accreditation of each program accredited over the past two years. Additional decision summaries will be added as they become available.

Now is the time to review the revised Annual Report which will be sent out in January 2023. The report also reflects improvements per the requirements of CHEA. Take a look now so you will be ready to respond in January. The reports will be due in March 2023.

**Organizations and Schools Accreditation (OSAC)** resources are here: <u>https://aerbvi.org/the-national-accreditation-council/organizations/</u>. The layout of the standards has been changed to reflect requests both from organizations seeking initial accreditation or re-accreditation. The main concern was lack of clarity as to the categories of the self-study forms. As always, the Management Standards must be completed by every agency or school for the blind pursuing accreditation. Now, the Program Standards are divided into two groups: standards for services to all ages, and standards for services particularly for birth through school-age consumers. Selections can be made from either or both groups.

Annual Update Forms and Invoices will be sent in January and will be due in March of 2023.
